OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

September 6, 2022

9:00 AM

Chairman Haman called the meeting to order. Commissioners Bryan Bruner, Larry Haman, Armann Anderson, David Medalen and Brady Nelson were present. Others attending were Gary Deibert and Dale Deibert.

A motion was made by Nelson and seconded by Anderson to approve the August 2nd minutes. Motion carried unanimously.

The board met with blade operator, John Bossert, regarding the formal referral. John agreed to sign the forms, which will be forwarded to the EAP.

A motion was made by Anderson and seconded by Nelson to approve the special event permit for the Thirsty Beaver on September 3rd, 2022. Motion carried unanimously.

A motion was made by Bruner and seconded by Anderson to sign the agreement with ND Emergency Services to provide dispatch services for McHenry County 911 calls. Motion carried unanimously.

A motion was made by Nelson and seconded by Bruner to send a letter of support to the US Department of Transportation, asking for continued funding for the UGPTI Safe Streets and Roads for All. Motion carried unanimously.

A motion was made by Anderson and seconded by Bruner to sign the agreement with the State of Minnesota Procurement Office for the Cooperative Purchasing Venture program, which will allow the county to receive state contracted pricing for motorgrader leases/purchases. Motion carried unanimously.

The board was presented with the monthly community service report.

A motion was made by Bruner and seconded by Medalen to designate the county courthouse as the polling location for the General Election on November 8. Motion carried unanimously.

A motion was made by Bruner and seconded by Anderson to install a 36" X 60' culvert on Co Rd 7 between Sections 4/5 in 151-78. Motion carried unanimously.

Lucille Loftesnes, Gary Deibert and Dale Deibert met with the board to request Co Rd 3 South of Granville be paved to Karlsruhe, which would be about 19 miles. The board estimated the cost at roughly \$1 million per mile and explained the funding is not there for that much pavement.

Jason Mayfield with Wold Engineering met with the board to discuss road projects. He mentioned the Army Corps of Engineers may require a variance on the new bridge NW of Upham due to the bridge not spanning the entire stream. Jason also mentioned Bottineau County is considering paving from Russell, South to the county line and will be asking McHenry County to pave from the county line to 80th St N. He estimated McHenry County's portion of the project to be about \$1.8 million.

The board conducted interviews with Wold Engineering (Jason Mayfield, Seth DeMontigny) and Ackerman-Estvold Engineering (Tim Arens, Austin Becker, Dylan Weber) for the preliminary engineering on project BRP-2500(022) to replace two bridges North of Granville.

The board recessed for lunch.

The board conducted interviews with Interstate Engineering (Travis Frey, Matthew Weeks) and Ulteig Engineering (J. Steven Windish, Mary Boechler) for the preliminary engineering on project BRP-2500(022) to replace two bridges North of Granville.

Sheriff Deputy Dewanz met with the board to present information on new body cams.

The Sheriff requested to attend a conference in Rapid City, SD. A motion was made by Nelson and seconded by Medalen to approve the request. Motion carried unanimously.

The board reviewed the scoring for the engineering interviews. A motion was made by Bruner and seconded by Anderson to select Wold Engineering. Motion carried unanimously.

A consent motion was made by Bruner and seconded by Anderson to approve the following: Treasurer's Miscellaneous Receipts #46778-46871; the monthly payroll in the amount of \$136,301.94 paid by warrant checks #27110-27162. Clerk of Court August County fees \$850.00, City of Towner \$20.00, City of Upham \$20.00, City of Velva \$20.00, State fees \$17,667.00; County Recorder August recording fees of \$5,499.00 and misc fees of \$754.18; Sheriff August statement of fees \$475.00, Sheriff mileage \$580.00, Deputy reports for July/Aug.
