OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

March 7, 2023

9:00 AM

Chairman Nelson called the meeting to order. Commissioners Bryan Bruner, Brady Nelson, Duane Drader, Lance Johnson and Armann Anderson present.

A motion was made by Anderson and seconded by Johnson to amend the January minutes to read section 14-158-76 when referring to possible bridge funding options. A motion was made by Johnson and seconded by Drader to approve the February 7th minutes. Motion carried unanimously.

A motion was made by Bruner and seconded by Johnson to sign the Contract for Construction with Mayo Construction for project CP-2507(023) to reshape and pave Co Rd 2 to Russell. Commissioners Johnson, Nelson, Bruner and Drader voting aye. Commissioner Anderson voting nay. Motion carried.

County Recorder, Johnna Torr met with the board to present information on a new scanner. The purchase will come out of the document preservation fund.

A motion was made by Anderson and seconded by Bruner to approve the raffle permit for the Towner Rodeo Association. Motion carried unanimously.

A motion was made by Drader and seconded by Anderson to approve the utility permit to Verendrye Electric to bore under Co Rd 19 just east of 18th Ave N for the purpose of placing a new cable. Motion carried unanimously.

A motion was made by Anderson and seconded by Bruner to approve the liquor and beer license for the Star City Golf Club. Motion carried unanimously.

A motion was made by Johnson and seconded by Anderson to extend the Murex Petroleum road agreement until November 1, 2023. Motion carried unanimously.

Tina Powell, Katelyn Crider with JLG Architects, Trey Skager and Josh Frey met with the board to discuss the courthouse remodel plans and architectural fee proposal. A motion was made by Johnson and seconded by Drader to sign the contract with JLG. Motion carried unanimously. JLG will move forward with preparing the plans to go out on bid.

Commissioner Nelson turned the meeting over to Vice Chair Anderson and left to attend a funeral.

Linda Fairbrother met with the board to ask if the board would like an audit prior to her retirement. A motion was made by Bruner and seconded by Drader to have an audit done. Motion carried unanimously.

A motion was made by Drader and seconded by Bruner to approve a floodplain permit for the NDDOT to mill and overlay a portion of Hwy 52 near Anamoose. Motion carried unanimously.

A motion was made by Johnson and seconded by Drader to send a letter of support to urge NDDOT to four-lane Hwy 52 from Minot to Voltaire. Motion carried unanimously.

The community service report for February was presented to the board.

A motion was made by Johnson and seconded by Drader to approve abatements 1450, 1452-1458. Motion carried unanimously.

Information regarding right-of-way encroachments along roads was shared with the board. This information will be shared with the townships.

County Extension personnel, Rachel Wald and Kendra Metcalfe, met with the board to review their quarterly projects. Presentations have been given to schools regarding vaping, Succession Planning classes will begin next week, On-the-Move nutritional classes will be starting, and the Stepping Out program will begin in Drake. The NDSU staff annual performance reviews will be held on March 28th and a commissioner is welcome to attend.

The board recessed for lunch.

A motion was made by Anderson and seconded by Drader to have Sidwell update the soils data. Commissioners Drader, Bruner, Nelson and Anderson voting aye. Commissioner Johnson voting nay. Motion carried.

Velva City Mayor and Auditor, Mike Schreiner and Jenny Johns, met with the board regarding the lack of an assessor for Velva City, due to a recent resignation. Velva City employed an assessor, who also acted as the city zoning administrator and building inspector. All cities and townships throughout the county contract with an assessor to complete their assessments. Velva City is considering vacating their position and relinquishing their assessing authority to the county. Since the County Tax Director has only been in office for less than a year, there has not been time for her to obtain her assessors certification, which generally takes about three years. Velva City will need to decide if they will pursue filling their position.

A motion was made by Johnson and seconded by Bruner to reappoint Corey Long to the county planning and zoning board. Motion carried unanimously.

The county received notification from NDDOT of two bridges that were approved to be replaced, which is bridge 25-115-04.0 located .5 miles West of Upham on Co Rd 16 and bridge 25-107-26.1 located on 15th Ave N, one mile North of Hwy 2 in Norwich Township.

The board will interview for the Blade Operator/Road Maintenance position at the April meeting.

The board discussed the rapidly increasing costs of maintaining roads. A motion was made by Johnson and seconded by Anderson to increase the road maintenance fee \$10/mile for townships to total \$200/mile due to a deficit of \$158,000 when comparing maintenance costs versus income. Motion carried unanimously.

A consent motion was made by Anderson and seconded by Drader to approve the following: Treasurer's Miscellaneous Receipts #47288-47361; the monthly payroll in the amount of \$143,148.57 paid by warrant checks #27420-27472; Clerk of Court Feb County fees \$610.00, State fees \$11,790.25; County Recorder Feb recording fees of \$3,293.00 and misc fees of \$535.98; Sheriff Feb statement of fees \$275.00, Sheriff mileage \$197.00, Deputy reports for Feb.

The board continued to audit bills until completed. A motion was made by Drader and seconded by Bruner that the following bills be approved and the proper checks be issued thereof:
