OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

September 5, 2023

9:00 AM

Chairman Nelson called the meeting to order. Commissioners Brady Nelson, Duane Drader, Lance Johnson and Armann Anderson present. Commissioner Bruner absent. Kelani Welstad was also present.

A motion was made by Drader and seconded by Anderson to approve the August 1st and 8th minutes. Motion carried unanimously.

Kristi Brummond joined the meeting. The board reviewed the variance application from Tyler Welstad to establish three tree rows, with the first row requesting to be 66' from the center of county road 16 located in the NW ¼ NW ¼ of Section 22-159-78. The county right-of-way is 66' from the center of the road. During the public hearing at the zoning board level, there was concern with future horizontal growth and encroaching in the county right-of-way as there has been discrepancies in the actual footage they were planted. Kelani stated they were planted at 66'. A motion was made by Johnson and seconded by Anderson to approve the variance at 66'. Commissioners Anderson, Johnson and Drader voting aye. Commissioner Nelson voting nay. Motion carried. The board stated the trees will be measured and all trees within the 66' right-of-way will need to be removed. The board also stated the county will not be responsible for damaging trees if they encroach within the 66' right-of-way if road work would need to take place.

The board reviewed the conditional use application from Roger Myers to establish a borrow clay pit located in N ½ of Section 20-151-78. A motion was made by Johnson and seconded by Anderson to approve the CUP, as recommended by the zoning board. Motion carried unanimously.

A motion was made by Drader and seconded by Anderson to approve the raffle permit for the Velva Wildlife Club. Motion carried unanimously.

A motion was made by Drader and seconded by Anderson to approve abatements 1477 and 1478. Motion carried unanimously.

A motion was made by Anderson and seconded by Drader to enter into a joint powers agreement with the ND Association of Counties for the collection and distribution of 911 fees. Motion carried unanimously.

A motion was made by Johnson and seconded by Drader to grant Sheriff Skager permission to attend an out-of-state conference in Aberdeen SD. Motion carried unanimously.

A motion was made by Drader and seconded by Anderson to accept a tree removal bid from The Ground Up to remove three trees on the courthouse grounds. Motion carried unanimously.

The board reviewed the August Community Service report.

A motion was made by Johnson and seconded by Drader to accept the contract police agreement from Upham City. Motion carried unanimously.

A motion was made by Drader and seconded by Johnson to accept the Juvenile Detention Services agreement with DJS and YCC. Motion carried unanimously.

A construction report was presented to the board regarding the dome project, which indicated all of the interior repairs have been made. The exterior repairs will resume in six to eight weeks with stripping of the paint, to follow with painting the dome in mid to late spring. The windows will then be installed which will complete the project.

A change order was received from JLG to fix the uneven subfloor in the new restroom and level the transition between the existing office and jury room where the wall was removed. A motion was made by Nelson and seconded by Johnson to approve the change order. A request was also made for the board to approve \$5,000 +/- to cover any changes from unforeseen conditions so construction will not be delayed until a board meeting. This request was denied.

A motion was made by Nelson and seconded by Drader to advertise for debris removal bids for various bridges throughout the county. Motion carried unanimously.

The board reviewed the current tax foreclosure list.

The board discussed holding the abandoned vehicle auction but a list has not been received from the Sheriff's Department. One of the commissioners will try to obtain a list.

A motion was made by Johnson and seconded by Drader to apply for state funding to replace the Halvorson Bridge NE of Upham. Motion carried unanimously.

A motion was made by Drader and seconded by Anderson to purchase four tires for the Towner blade. Motion carried unanimously.

A motion was made by Johnson and seconded by Anderson to advertise for bids for concrete and floor heat for a new 40' x 60' shop in Upham. Motion carried unanimously.

A motion was made by Nelson and seconded by Johnson to purchase tires and a windshield for the plow truck in Granville. Motion carried unanimously.

A consent motion was made by Anderson and seconded by Drader to approve the following: Treasurer's Miscellaneous Receipts #47868-47952; the monthly payroll in the amount of \$146,243.07 paid by warrant checks #27719-27767; Clerk of Court July County fees \$665.00, State fees \$13,895.10, Velva City \$20.00; Towner City \$60.00; County Recorder July recording fees of \$4,437.00 and misc fees of \$353.94; Deputy reports for June/July.

The board continued to audit bills until completed. A motion was made by Drader and seconded by Anderson that the following bills be approved and the proper checks be issued thereof:
