## OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

July 2, 2024

9:00 AM

Vice Chairman Anderson called the meeting to order. Commissioners Bryan Bruner, Duane Drader, Lance Johnson and Armann Anderson present. Commissioner Nelson absent.

A motion was made by Johnson and seconded by Drader to approve the June 4<sup>th</sup> minutes. Motion carried unanimously.

A motion was made by Bruner and seconded by Drader to pursue leasing a tractor for the summer of 2025. Motion carried unanimously.

A motion was made by Bruner and seconded by Drader to approve raffle permit #79 for the Velva Saddle Club. Motion carried unanimously.

States Attorney Josh Frey and Sheriff Trey Skager joined the meeting. Skager suggested looking into a county credit card to be used for county purchases. Skager left the meeting.

Mark Larson, Terry Domres, Robert Martin, James Rognlien and Alli Rognlien met with the board to discuss a land access/section line issue. A motion was made by Johnson and seconded by Drader to table this until the August 6<sup>th</sup> meeting at 11:00 AM. Motion carried unanimously.

The board recessed for lunch.

Rachel Wald met with the board to give an update on the activities the extension office has recently been involved with.

Johnna Torr and Tina Powell met with the board to request the courthouse be closed on July 5<sup>th</sup>. A motion was made by Drader and seconded by Bruner to approve the request. Motion carried unanimously.

First District Health Director Holly Brekhus, Amy Silverwood-Miranda and Nancy Bryn were in attendance for the FDHU budget hearing. No one appeared in opposition. Holly presented information on the services they provide as well as the number of people served. Holly also shared information on the new mental health awareness program, Credible Mind, which can be accessed on their website. A motion was made by Bruner and seconded by Drader to approve the budget request. Motion carried unanimously.

The plat for the Buffalo Lodge Cottage 6<sup>th</sup> Addition was presented to the board for approval. A motion was made by Drader and seconded by Bruner to deny the plat and require a new plat that designates the roads be private to match the designation on the previous plats. Motion carried unanimously.

The board will hold a budget meeting on July 16 at 9:00 AM.

A motion was made by Bruner and seconded by Drader to approve the new funding agreement with the ND Department of Emergency Services to provide 911 services to McHenry County. Motion carried unanimously.

Commissioner Johnson informed the board of a request from the Towner Fire Department to install an approach along Co Rd 5, North of the water tower. A motion was made by Drader and seconded by Bruner to deny the request. Commissioners Drader, Bruner and Anderson voting aye. Commissioner Johnson voting nay. Motion carried.

A consent motion was made by Johnson and seconded by Drader to approve the following: Treasurer's Miscellaneous Receipts #4887-49005; the monthly payroll in the amount of \$165,062.18 paid by warrant checks #28162-28213; Clerk of Court May County fees \$730.00, State fees \$21,480.77; County Recorder June recording fees of \$2,842.00 and misc fees of \$345.34; Deputy reports for Apr/May.
