## OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

October 7, 2025

9:00 AM

Chairman Anderson called the meeting to order. Commissioners Lance Johnson, Brady Nelson, Bryan Bruner, David Schmitt and Armann Anderson present.

A motion was made by Nelson and seconded by Johnson to approve the September 2<sup>nd</sup>, 19<sup>th</sup> and 26<sup>th</sup> minutes. Motion carried unanimously.

Harry Nelson met with the board regarding the damage that occurred along Co Rd 8 when CTI dropped an excavator in the ditch. The board will obtain bids from contractors who have a long-reach to repair this site before freeze-up.

A motion was made by Nelson and seconded by Schmitt to approve a special event permit for Finishline Burgers & Brew for an event on November 29, 2025. Motion carried unanimously.

A motion was made by Johnson and seconded by Bruner to approve the jail contracts with Ward and Pierce Counties. Motion carried unanimously.

Frank Anderson and Brad Murphy joined the meeting to discuss the options for the two blades that the leases will be expiring on soon. A motion was made by Johnson and seconded by Bruner to buy the leases out. Motion carried unanimously. Frank provided information on some used skidsteers/Bobcats.

The board opened the public hearing for the 2026 FDHU and county budgets. Sheriff Skager and Leonard Bischoff joined the meeting. No one appeared for or against the FDHU budget. A motion was made by Johnson and seconded by Schmitt to approve the FDHU 2026 budget as presented. Motion carried unanimously. No one appeared for or against the county budget. Leonard Bischoff voiced his concerns with the Towner Ambulance levy. The board heard his concerns but informed him they have no control over the ambulance budget and that he needed to attend the budget hearing for the ambulance district. Trey questioned the board regarding the decrease in overtime, which they explained. Trey mentioned they will need additional funds to purchase a new vehicle since the request through the Stonegarden grant was not approved. The board decided to use \$37,000 of reserves to cover the additional cost. A motion was made by Bruner and seconded by Schmitt to approve the 2026 budget as amended. Motion carried unanimously.

Steff Basgaard with Knife River was in attendance for the review of the conditional use application to mine aggregate and place a hot mix asphalt plant in Section 3 and 10 of 153-79, also known as the Colby Pit. There was some opposition to this at the public hearing held with zoning board from Mark Feist and Wade and Lori Lagge regarding safety issues with all the truck traffic. They requested the route be changed, which would be a township matter. Commissioner Nelson stated his frustration with Knife River, as they have not been properly maintaining the haul roads used by the Verendrye pit. Nelson emphasized the need for Knife River to be blading the haul road used from the Colby Pit, due to the amount of truck traffic. A motion was made by Nelson and seconded by Johnson to approve the Conditional Use Permit, adding the condition that if the road maintenance agreement with the township is not being fulfilled, the CUP will be revoked. Motion carried unanimously.

The board reviewed the variance application from David Bolduc to construct a polebarn 130' from the center of 15<sup>th</sup> Ave N in the NE1/4 NE1/4 of Section 11-153-80. The zoning board recommended to approve the permit. A motion was made by Nelson and seconded by Bruner to approve the variance. Motion carried unanimously.

Jodie Frankl with Globe Life Family Heritage Insurance met with the board to explain the coverage she has to offer.

The board recessed for lunch.

Jason Mayfield met with the board and presented estimates for the projects submitted for Flex funds through the state. The projects were to reshape and widen Co Rd 19 and mill and overlay Towner North. Jason also provided estimates for the five bridge removals and one replacement that have been placed on the short list with NDDOT. The county will be notified by the end of the year of the projects selected by NDDOT.

The board set the minimum sales prices for the county land to be sold at the county land sale on November 18<sup>th</sup>. A motion was made by Bruner and seconded by Schmitt to approve the prices. Motion carried unanimously.

A motion was made by Nelson and seconded by Bruner to issue the proper deed to James Haskins for the redemption of county property described as Lots 11-12 of Block 8 in Original Anamoose. Motion carried unanimously.

A motion was made by Bruner and seconded by Schmitt to reappoint Joan Gunter and Jerry Effertz as county delegates on the ND State Fair Board. Motion carried unanimously.

A motion was made by Bruner and seconded by Nelson to approve abatements 1649-1652. Motion carried unanimously.

A motion was made by Bruner and seconded by Johnson to sign the MOU with the Secretary of State office regarding the ownership and maintenance of election equipment. Motion carried unanimously.

A motion was made by Bruner and seconded by Schmitt to enter into a 5-year contract with Sidwell for the Portico (GIS) system. Motion carried unanimously.

A motion was made by Johnson and seconded by Nelson to approve the extension of the overweight permit for Murex Petroleum until May 1, 2026. Motion carried unanimously.

One bid was received for the cement bridge decks in Granville. A motion was made by Nelson and seconded by Schmitt to accept the bid, pending they are aware the bid was for purchasing and not disposal. Motion carried unanimously.

The board conducted interviews for the Towner blade operator position.

Cliff and Mary Hanretty met with the board to get an update on the bridge. The board did apply for Flex funding, but it was denied by NDDOT. Gravel has been placed on a trail to the west of Hanretty's to improve that access.

A motion was made by Nelson and seconded by Bruner to place salted sand in Upham. Motion carried unanimously.

A motion was made by Nelson and seconded by Anderson to offer the Towner blade operator position to Dustin Johnson. Motion carried unanimously.

A consent motion was made by Johnson and seconded by Nelson to approve the following: Treasurer's Miscellaneous Receipts #50551-50666; the monthly payroll in the amount of \$180,760.67; County Recorder September recording fees of \$4,339.00 and misc fees of \$279.02; Sheriff August statement of fees \$270.00, Sheriff mileage \$560.00, Sheriff September statement of fees \$1,100.00, Sheriff mileage \$1,012.00, Deputy reports for Aug/Sept.

The board continued to audit bills until completed. A motion was made by Schmitt and seconded by Nelson that the following bills be approved and the proper checks be issued thereof:
